Dear international student,

the content of this Pocket guide is designed to help you in your first days after your arrival in Ljubljana, and to provide you with some basic useful information.

Subsidized student meals – "boni"

Students in Slovenia can eat at a very reasonable price in almost any restaurant in town. The subvention for meal is 2,63 EUR. To join the system of subsidized student meals just follow these steps: 1) get a Slovenian SIM card for your mobile phone, 2) register online

(*) studentska-prehrana.si/en, 3) go to student Kampus
(Pivovarniška ulica 6) to complete the application process and activate the phone number.

The things to bring with you: 1) a student ID card or the original certificate of registration, 2) Social Security Number EMŠO and 3) a valid ID card or passport.

Accommodation

The accommodation for international students in student dormitories are limited and primarily reserved for foreign students coming in the frame of Erasmus+ and CEEPUS study programme. **Private accommodation:** contact \boxtimes rooms@sou-lj.si or visit the International Office of the University Student Organization – ŠOU. **Temporary accommodation:** () www.visitljubljana.com where you can find a list of accommodation offered in Ljubljana. Language Requirements and Slovene language courses

Public transport in Ljubljana - BicikeLJ

The most effective means of public transport in Ljubljana is the city bus and the city bike. The bicycle rental requires prior registration at registration at requires prior registration at student bus pass – the green URBANA card

For 20 EUR per month, the student bus pass is a cost-effective way to travel around Ljubljana. It is available from 1st October on. You can get the subsidized monthly pass at the TLPP, Slovenska cesta 56, Ljubljana (office hours between 7 am and 7 pm) or at the main bus station. You will need EMŠO number. Value bus pass – the yellow URBANA card

If you don't intend to ride buses regularly, you can get the transferable yellow Urbana value card and top it up according to your needs. One ride costs 1.30 EUR.

Health

In case of health problems, you are advised to contact Zdravstveni dom za študente (**Health Center for Students**), Aškerčeva 4, Ljubljana. To receive free health services, you need a European Health Insurance Card or an insurance policy.

Health Insurance Institute Slovenia Mala ulica 3, 1000 Ljubljana www.zzzs.si, Xanja.Kobentar@zzzs.si. According to Slovenian legislation, students who work in laboratory and take field trips as part of the course need to be insured for accidents at work. The insurance costs 126.58 EUR/month.

Residence permit

If you are staying in private accommodation, report your temporary address to the nearest police station within a week. If you are staying in Slovenia for more than three months you should apply for the temporary (first) residence permit which can be obtained at **Upravna enota.** Apply for the temporary (first) residence permit within 3 days at Upravna enota.

Documents that you need:

1) a valid ID or passport, 2) Acceptance letter – original, 3) Health insurance covering all risks in the host member state, 4) Sufficient means for living (400€ per month), 5) Photo (biometrical 3,5x4,5cm). The temporary residence permit will be issued in accordance to the conditions set by the European Union.

Residence permit for non-EU citizens

If you are a third-country national from a country whose citi¬zens are required to obtain a visa to enter the Republic of Slove¬nia and you wish to enter the Republic of Slovenia or stay there for study purposes, you are required to obtain a visa C (tourist visa) or visa D (long term visa) at a diplomatic mission or con¬sulate of the Republic of Slovenia abroad prior to entering the Republic of Slovenia. For the same purposes, you can enter the Republic of Slovenia and stay there for a certain period of time (for no more than three months in a six-month period, starting on the date of the first entry) on the basis of your passport alone if you are a citizen of a country whose citizens are not required to obtain a visa to enter the Republic of Slovenia. Within the 90 day period or after the expiration of Visa D, you are obliged to apply for a first residence permit at the relevant administrative unit in Slovenia (in Ljubljana: Tobačna ulica 5, 1000 Ljubljana).

Documents that you need:

1) a valid passport, 2) acceptance letter – original, 3) health insurance covering urgent health care services in the Republic of Slovenia as a minimum requirement, 4) sufficient means of subsistence in a monthly amount at least equal to the basic minimal income (app. 400 € per month), 5) Photo (biometrical 3,5x4,5cm), 6) a police clearance certificate not older than 3 months from your country, translated into Slovenian and verified.
